Terms & Conditions For Buyers

<u>BUYERS:</u> Carefully read the terms and conditions of sale for this auction, and conduct a thorough presale examination of any horse of interest before bidding. Listen carefully to all announcements made from the auction block. Horses become the buyer's responsibility once the auctioneer has declared the winner.

Presale Exam: All prospective Bidders/Purchasers are urged to carefully examine horses in which they may be interested (personally and/or by Agents or veterinarians of their choosing) BEFORE bidding, as they are accepting any horse purchased with any and all faults, including all conditions and defects. In all other respects, the AS IS nature of this sale remains in full force and effect. All prospective Bidders/Purchasers acknowledge presale exams may be conducted by physically viewing the horse, if available, by video, by photos, or through an Agent. All prospective Bidders/Purchasers further acknowledge that if the presale exam is insufficient as determined in the sole discretion of the prospective Bidder/Purchaser, said prospective Bidder/Purchaser shall not bid on the horse. Purchaser's duty of full inspection shall include a review of all such documentation and information. It is strongly expected that all prospective buyers conduct a thorough examination of conformation and gait, ground behavior, and ride the horse before bidding. Make sure that you have thoroughly inspected and approve of the horse you are bidding on. There is no return policy on horses sold through the sale.

MVLA & its associates act as agents only and are not responsible for buyer/seller error or misunderstanding. All guarantees are strictly between the buyer and seller.

All risk of injury to, and responsibility for, the horse becomes Buyer's risk at the fall of the hammer. Title passes to Buyer upon completion of payment. Buyer and seller agree to release, defend, indemnify and hold owners, managers, and employees harmless from all losses, expenses, and claims related to the possession, care, custody, control or maintenance after the fall of the hammer of any horse on which he or she is the successful bidder, whether resulting in whole or in part from their own negligence, including but not limited to any claims arising out of injuries or damage caused by the horse after the fall of the hammer.

#### **Catalog Information**

However, as each horse enters the sale ring, all participants are cautioned to pay close attention to the announcements made during the sale regarding changes in or additional information from that found in the sale catalog, as such announcements take precedence over the catalog printed material. The catalog and warranty information in the auction process is provided by and is the sole responsibility of the owner. It is also the owner's responsibility to make certain that only correct statements are made public before or while the horse is in the auction arena.

#### **Settlement of Account**

Settlement of account for any purchase shall be made directly to the sales cashier by the buyer and is to be paid in full on the day of the sale. Methods of payment shall be cash, cashier's check, personalized bank checks, or debit or credit card, with a 3 percent surcharge added to all debit or credit card payments. No postdated checks will be accepted.

A driver's license is required for buyer registration and personal checks. NO delivery of title will be made until final settlement has been transacted. Upon payment by the buyer to the sale cashier, the cashier will issue a document to the buyer, which will release the horse from the auction grounds.
